PEREZ TO ENTER INTO AND SIGN, FOR AND IN BEHALF OF THE LOCAL GOVERNMENT OF PILAR, THE MEMORANDUM OF AGREEMENT (MOA) WITH THE CAPIZ STATE UNIVERSITY REPRESENTED BY ITS PRESIDENT DR. EDITHA C. ALFON FOR THE IMPLEMENTATION OF THEIR EXTENSION PROGRAMS AT THE MUNICIPALITY OF PILAR.

WHEREAS, the Memorandum of Agreement (MOA) to be entered into by and between the Local Government of Pilar and the Capiz State University states the obligation of both parties in the implementation of the Programs;
