RESOLUTION GRANTING AUTHORITY TO THE MUNICIPAL MAYOR TO ENTER INTO AND SIGN, FOR AND IN BEHALF OF THE LOCAL GOVERNMENT OF PILAR, THE MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES - ENVIRONMENTAL MANAGEMENT BUREAU – REGION VI (DENR-EMB) TO ACCEPT THE ECOLOGICAL SOLID WASTE MANAGEMENT EQUIPMENT FROM THE DENR-EMB FOR THE IMPLEMENTATION OF LOCAL SOLID WASTE MANAGEMENT PLANS AND PROGRAMS.

WHEREAS, the Memorandum of Agreement (MOA) to be entered into by and between the Local Government of Pilar and the Department of Environment and Natural Resources - Environmental Management Bureau – Region VI (DENR-EMB), defines the term and conditions for the implementation of Local Solid Waste Management Plans and Programs;

WHEREAS, Solid Waste Management is a pervasive problem and a looming crisis in many areas in the Philippines, focusing for decades on collection and hauling and not on waste treatment and disposal, thus management has become expensive and unsustainable;

WHEREAS, Section 8 of Republic Act 9003 otherwise known as Ecological Solid Waste Management Act of 2000 states that the Department of Environment and Natural Resources - Environmental Management Bureau (DENR-EMB) shall provide technical and other capability building assistance and support to the LGUs in the development and implementation of local solid waste management plans and programs;

WHEREAS, the Sangguniang Bayan in complete attendance went over the stipulations in Memorandum of Agreement of the two parties and interposes no objection to the MOA and fully support the undertaking:

WHEREAS, the Municipality of Pilar, has agreed to be a recipient/beneficiary of a set of Ecological Solid Waste Management Equipment from the Department of Environment and Natural Resources - Environmental Management Bureau (DENR-EMB);

WHEREAS, there is a need to ensure the effective implementation of the aforementioned project, thus, a MOA is essential;




