**RESOLUTION RESPECTFULLY REQUESTING FOR ADDITIONAL TWENTY-FOUR (24) UNITS OF OXYGEN TANK TO BE DISTRIBUTED TO ALL BARANGAYS IN THE MUNICIPALITY OF PILAR.**

**WHEREAS**, the 1987 Constitution provides that the state shall protect and promote the right to health of the people and in still health consciousness among them;

**WHEREAS**, the Local Government Code of 1991 provides under the General Welfare Clause that every Local Government Unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of general welfare;

**WHEREAS**, the recent emergence of COVID -19 pandemic poses unprecedented threat to the health of the entire nation and that includes the people of the Municipality of Pilar;

**WHEREAS**, it is imperative to protect the health of our constituents that measures are in place to properly prevent, manage, monitor and assess the disease, its transmission, spread and its containment that all necessary medical supply and equipment be in place;

**WHEREAS**, the Local Government Unit of Pilar had previously acquired and distributed oxygen tanks to all the barangays within this Municipality;

**WHEREAS**, due to its frequent usage, it was proven that said oxygen tanks are necessary and needs to be augmented to maintain its availability at all times in the barangay.

**NOW THEREFORE**, premises considered and upon the motion of **HON. ANGELA JOY A. TUPAS** which was duly seconded by all SB members present in session: **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve **RESOLUTION RESPECTFULLY REQUESTING FOR ADDITIONAL TWENTY-FOUR (24) UNITS OF OXYGEN TANK TO BE DISTRIBUTED TO ALL BARANGAYS IN THE MUNICIPALITY OF PILAR.**
